**RELATIVE TO EXPRESSING APPRECIATION TO JILLETTE T. LEON GUERRERO
FOR HER SERVICE AS A MEMBER, AND VICE CHAIRPERSON OF THE
BOARD OF REGENTS**

WHEREAS, upon the completion of Jillette T. Leon Guerrero's term as a member and Vice Chairperson of the Board of Regents (BOR), the University of Guam (UOG) community wishes to express its sincere gratitude for her dedication and service;

WHEREAS, Jillette T. Leon Guerrero earned a B.A. in Anthropology with a minor in Micronesian Area Studies from UOG, graduating magna cum laude in 1981; and earned a master's degree in Human Relations from the University of Oklahoma in 1992; completed coursework in Fundraising Management from the Fundraising School University of Indiana/University of Purdue in Indianapolis;

WHEREAS, Jillette T. Leon Guerrero is the President and Founder of Guamology Inc., a business dedicated to providing the community with information and resources about Guam, its history and people;

WHEREAS, Jillette T. Leon Guerrero served on numerous civic organizations to include the Guam Women's Club as past President, Vice President and Treasurer;

WHEREAS, Jillette T. Leon Guerrero was confirmed as a member of the BOR on December 11, 2012 to serve a full six-year term ending December 10, 2018, and continued to serve in an acting holdover capacity, as authorized by PL 29-113, until April 24, 2019;

WHEREAS, Jillette T. Leon Guerrero served as Vice Chairperson of the BOR from April 26, 2018 to February 13, 2019; and served on various BOR Ad Hoc Committees, to include a Dispute Panel Committee for Unfair Labor Practice from March 24, 2016 to August 10, 2016;

WHEREAS, as a member of the BOR, Jillette T. Leon Guerrero served on: the Academic, Personnel and Tenure Committee (AP&T) as a member from August 2012 to June 2013, then as Chair from September 2013 to February 2019; the Budget, Finance, Investment and Audit Committee as a member from September 2013 to September 2017; and the UOG Endowment Foundation Board of Directors as an Ex Officio member from June 2013 to September 2017;

WHEREAS, Jillette T. Leon Guerrero represented the BOR as a member of the Research Corporation of the University of Guam (RCUOG) Board of Directors from December 2017 to April 2019;

WHEREAS, Jillette T. Leon Guerrero brought experience and knowledge as a successful professional and a responsible leader to the BOR, and provided valuable influence in working with both policy makers and the Administration in addressing issues impacting UOG;

WHEREAS, Jillette T. Leon Guerrero's commitment and leadership in support of UOG and higher education as a BOR member is recognized, commended and greatly appreciated;

WHEREAS, Jillette T. Leon Guerrero is highly regarded for her humility, amiability, diligence, sound judgement and holistic consideration in decision-making; and

WHEREAS, the AP&T Committee has reviewed the recommendation and recommends approval of this resolution expressing appreciation to Jillette T. Leon Guerrero to the BOR.
