2.0 MEETING MINUTES

2.1 Regular Meeting Minutes of February 20, 2014

Vice Chairperson W. Leon Guerrero moved for the approval of the Regular Meeting Minutes of February 20, 2014 subject to corrections, which was duly seconded. The motion carried.

3.0 CHAIRPERSON'S REMARKS

Chairperson Perez thanked the Charter Day committee for their hard work in planning a wonderful event that showcased the University. He noted that former Regent Sgro was recognized in the newspaper over the past few months, as well as CPFO Sonny Perez who was highlighted in the Bayanihan, and commended them for their accomplishments.

Chairperson Perez noted that Student Regent-elect Vinni Orsini will be succeeding Regent Quenga and expressed his gratitude to Regent Quenga for his service over the past two years. He then wished everyone a blessed Easter on behalf of the BOR. He thanked everyone for their prayers as he continues to undergo treatment, which is continuing.

4.0 PRESIDENT'S REPORT

President Underwood noted that as the press announcements are being shared directly with the regents to keep them abreast of University announcements, he is attempting to shorten his report. He then gave the President's report, a summary of which is attached.

Chairperson Perez asked Interim SVP Enriquez to introduce those recently tenured professors who are present this evening to be recognized by the BOR. Interim SVP Enriquez introduced Dr. Fred Schumann, Associate Professor of Global Resources Management, noting his contributions and participation in tourism activities in Guam. Dr. Schumann stated that he came to the university as a student living in the dorm in 1979, returning to the University in 2009 as a professor. He expressed his thanks for allowing him to continue to serve at the University.

Interim SVP Enriquez introduced Dr. Karri Perez, Associate Professor of Global Resources Management, noting she also came to the University at the same time as Dr. Schumann, noting her background in private enterprise and her many notable publications. Dr. K. Perez thanked the Board and stated that she truly appreciates the opportunity to work with the students and give back to the community.

Interim SVP Enriquez introduced Dr. Kevin Ho, Associate Professor of Management Information Systems, remarking that he has served as a bridge between the University with both Hong Kong and China, and is well published, in demand as a collaborator and researcher, and has a focus in the area of electronic auctioning and bidding. Dr. Ho thanked the Regents and explained his work with management information systems.

Interim SVP Enriquez introduced Professor Paul Drake, Associate Professor of Library Science, who is highly engaged and has contributed greatly to the University in promoting information literacy as a core competency across campus. Mr. Drake expressed his appreciation to the BOR and the administration for their encouragement and support with his research, reporting that he received a financial award that allowed him to contribute further to local and regional efforts.

Chairperson Perez thanked all of the professors for their work and service to the University and its students.

Administration for Children and Families, Administration for Native Americans (ANA) to Support the University of Guam Proposal "ESTORIAYI I FAMAGU'ONTA"

Regent J. Leon Guerrero introduced Resolution No. 14-09 for information only, and explained the purpose and effect of the resolution. Chairperson Perez noted that the Resolution has been executed by President Underwood and himself, as authorized by previous BOR action. As requested by the Chairperson, Regent Sanford explained that the title of the proposal means "to tell the story of and to our children."

Regent Sanford introduced Resolution No. 14-10 and explained the intent of the program. The motion was duly seconded and carried.

5.2.2 Resolution No. 14-11, Relative to Approving the Spring 2014 Commencement Graduate Listing

Regent Sanford introduced Resolution No. 14-11, which was duly seconded. The motion carried.

5.2.3 Resolution No. 14-12, Relative to Awarding the Honorary Degree of Masters of Micronesia Traditional Knowledge to Mr. Candido Babauta Taman

Regent Sanford introduced Resolution No. 14-12, noting that Mr. Taman has been nominated based on his contributions to Micronesian music. President Underwood summarized Mr. Taman's accomplishments. The motion was duly seconded and carried. Chairperson Perez requested that the Commencement committee ask if Mr. Taman could grace the audience with a song at the Commencement Ceremony.

VPAF O'Brien also announced an upcoming investment training event for the BOR which he will send out information about later.

Regent Gayle noted that the USDA may have additional requirements in support of the loan application by the UOG Endowment Fund (UOGEF) for the financing of the Student Services Center and the Engineering Annex. She introduced a motion to authorize the Chairperson of the BOR or the Chairperson of the Physical Facilities Committee to review and approve information to be provided to the USDA as required in order to further process the UOGEF's direct loan application and that the BOR Executive Secretary attest to such approval as required. The motion was duly seconded and carried.
