WHEREAS, Andrew T. Laguaña is a public servant and is active in the community, having served many organizations including the Guam PEALS Board as a member and former Chairman, the Western Conference of Architectural Registration Boards (WCARB) Region 6 as member and member of the Executive Committee, UOG Micronesian Area Research Center as a member, Rotary Club of Guam as a Member, Young Men's League of Guam Board as a Director, Academy of Our Lady of Guam Advisory Board as former member and Chairman, Guam Preservation Trust Guam Historic Preservation Review Board as Chairman, and the University of Guam Board of Regents; and

WHEREAS, Andrew T. Laguaña has received multiple awards and recognition to include being the first recipient of AIA Guam & Micronesia Chapter's Scholarship to attend the Masters Program at University of California — Berkeley, College of Environmental Design (1974), receiving a certificate of appreciation from the Micronesia Area Research Center (MARC) UOG for significant contributions to its development during its first 25 years of existence (1992), Merit Award and Special Citation Award from the AIA Guam & Micronesia Chapter Awards (1997), certificate of appreciation from the Guam Preservation Trust for his sustained interest in preserving archival materials on Guam (1995), Guam Visitors Bureau Award for the Most Outstanding Cultural Tourism Project (1996), certificate of appreciation from the Capuchin Friars for his assistance in the design and construction of the new St. Fidelis Friary, Winning Firm of Design Competition for the Guam Museum (2008), Member of the Year Award from the Young Men's League of Guam (2008), Golden Jubilee Achievement Award from the Professional Engineers, Architects & Land Surveyors (PEALS) Board (2010), Na' La' Bonita Guam award by the Guam Chamber of Commerce Partners in Progress (2010),

WHEREAS, Andrew T. Laguaña, through his active participation and shared professional knowledge, contributed significantly to the quality of the BOR's performance of its duties and responsibilities and to the development of the University's Physical Master Plan; and

WHEREAS, Andrew T. Laguaña is highly regarded for his commitment and collegiality; and
