RELATIVE TO EXPRESSING APPRECIATION TO ANTHONY R. QUENGA FOR HIS SERVICE AS A MEMBER OF THE BOARD OF REGENTS

WHEREAS, on the completion of his term as a student member of the Board of Regents, the University of Guam community wishes to express its sincere gratitude to Anthony R. Quenga; and

WHEREAS, Anthony R. Quenga is the son of Mary Ann Quenga, and graduated from Southern High School in May 2008; and

WHEREAS, Anthony R. Quenga began attending the University of Guam in August 2008, graduated with a B.B.A. in International Business, Marketing and Finance & Economics Concentrations in May 2013, and began his graduate studies at the University of Guam in August 2013; and

WHEREAS, Anthony R. Quenga is active in the community, having provided volunteer service to Southern High School and Junior Achievement of Guam's Company Program, been cast and involved with various community theatre productions, and is currently the Speaker of the 29th Guam Youth Congress (January 2013 to present); and

WHEREAS, Anthony R. Quenga is a singer and Travelling Tour Member of the University Singers for the 2010 Czech Republic Tour (Silver Medal with the University Singers), 2011 Thailand & Cambodia Tour (Gold Medal with the University Singers), 2012 Italy Exhibition Tour, 2013 Guam International Choir Competition (Gold Medal with the University Singers), and was a recipient of the "No Life Award" by the University Singers for being a contributing member for eight consecutive semesters; and
