## Resolution No. 19-35

## RELATIVE TO THE EXERCISE OF THE FINAL OPTION OF A CONTRACT FOR REGISTERED INVESTMENT ADVISOR SERVICES

WHEREAS, the University of Guam (UOG) is the primary U.S. Land Grant institution accredited by the WASC Senior College and University Commission (WSCUC) serving the post-secondary needs of the people of Guam and the region;

WHEREAS, the governance and well-being of UOG is vested in the Board of Regents (BOR);

WHEREAS, the BOR has the authority to make and set administrative policies for the furtherance of the mission of the University;

WHEREAS, in 2015 a solicitation for a Registered Investment Advisor for the BOR and the University was issued with a term of three years and two options to extend for an additional one year period;

WHEREAS, the BOR approved the selection of Raymond James & Associates (RJA) as the provider of Registered Investment Advisor services to the University as well as the transfer of all investment accounts from the previous provider to RJA;

WHEREAS, the President requests the BOR to exercise the option to appoint RJA as Registered Investment Advisor for the fifth and final term; and

**WHEREAS**, the Investment Committee has reviewed this request and recommends approval by the BOR.

NOW, THEREFORE, BE IT RESOLVED, that the BOR hereby approves the exercise of the final one year option on the contract with RJA.
