Resolution No. 24-27

RELATIVE TO APPROVING THE PROPOSED ADJUSTMENT OF CERTAIN STUDENT FEES EFFECTIVE FANUCHÅNAN SEMESTER 2025

WHEREAS, the University of Guam (UOG) is the primary U.S. Land Grant and Sea Grant institution accredited by the Western Association of Schools and Colleges Senior College and University Commission serving the post-secondary needs of the people of Guam and the Western Pacific region;

WHEREAS, the governance of UOG is vested in the Board of Regents (BOR),

WHEREAS, UOG from time to time re-evaluates fees charged to student to ensure that the fees are reasonable and are used for their intended purpose; and

WHEREAS, there are several types of fees at UOG, specifically, General Fees which are paid by all students; Course Fees, paid by students taking certain UOG courses; Service Fees, paid by students for certain services offered at UOG; and Resident Halls Fees, paid by residents of UOG Student Housing; and

WHEREAS, UOG has proposed the adjustment to General Fees, specifically the Recreation/Wellness, Sports, and Fieldhouse Fee; the Health Services Fee; the Computer and Internet Fee; the Online Learning Fee; the Graduation Fee; the Residence Halls Fees; the establishment of a new Facilities Maintenance Fee; and the establishment of new Program Fees at the School of Engineering and School of Health, all of which are detailed in Attachement A of this resolution;

WHEREAS, the University has determined that in order to lessen the need for significant one time increases in fees and lessen the impact on students from sudden increases in the future, fees should be adjusted on an automatic basis based on the U.S. Consumer Price Index for the preceding year;

WHEREAS, the University has proposed fee rate changes and made them publicly available with an economic impact statement per 5 GCA Article 3 Section 9301 (f); and

WHEREAS, at their respective November 2024 meetings, the Student Affairs, Scholarship, Alumni Relations, and Honorary Degree (SASARHD) Committee and the Budget, Finance and Audit (BFA) Committee reviewed the proposed fees adjustment and held a joint public hearing on November 12, 2024 to receive input on the proposed fees; and

WHEREAS, the Committees and the President recommend to the BOR the approval of the proposed fees adjustment in Attachment A; and

NOW, THEREFORE BE IT RESOLVED, that the Board of Regents hereby approves the proposed adjustment to student fees as detailed in Attachment A of this resolution;

BE IT FURTHER RESOLVED, that the President is delegated the authority to defer the adjustment of fees or any individual fee should the President determine that the adjustment have a negative impact on the operation of the University;

BE IT FURTHER RESOLVED, that the President is delegated the authority to determine the timing and application of the School of Engineering and School of Health program fees;

BE IT FURTHER RESOLVED, that the President is delegated the authority to "grandparent" fees without a public hearing in instances where a new or existing course/program without a fee, requests a fee that is similar enough to currently approved fees and has already been approved by the BOR.
