MINIMUM QUALIFICATIONS:

- Bachelor's degree in a field of STEM (Science, technology, engineering and mathematics) and be computer literate.
- The finalist needs to be enrolled in Environmental Science graduate program at the University of Guam as soon as possible upon employment.
- Background and/or willing to be trained in GIS/remote sensing, computer programming in Python, VBA or other programming languages.
- Be reliable, have organizational and social skills, and demonstrate ability to work independently under minimum supervision.

KNOWLEDGE, ABILITIES, AND SKILLS:

Must be computer literate. Ability to use ArcGIS software

QUALIFICATIONS REQUIRED: Pursuant to Public Law 26-87 as amended by Public Law 29-113, all future employees of any position within the government of Guam will be required at minimum to possess one of the following:

1. A high school diploma, or
2. Successful completion of General Education Development (GED) Test; or
3. The equivalent of a general education high school program; or
4. Successful completion of a certification program, from a recognized accredited or certified vocational technical institution, in a specialized field for the job.

DUTIES AND RESPONSIBILITIES:

Under the direct supervision of the WERI faculty in GIS, the Research Assistant II will assist the faculty's research projects focusing on geospatial and statistical analysis of the occurrence, magnitude, distribution, associations, and trends of salinity in Guam's drinking water production wells. Duties including selecting and processing salinity data available from Guam Waterworks Authority (GWA) and other sources, and linking such information to a point-feature class (e.g., well locations) so that it can be applied in GIS-based analysis and visualization. The work will focus on visualization and analysis of patterns and trends of salinity in Northern Guam Lens aquifer (NGLA), and determination of factors affecting the salinity levels. Products will include maps, charts and analyses about salinity for individual wells and groups of wells in NGLA. Successful applicant will receive salary, and tuition and fees will be covered for coursework and thesis credits leading toward a Master of Science degree in environmental science.

EDUCATION:

Applicants claiming degrees or credit hours are required to have an original or certified copy of the documents (e.g., Transcripts, high school diploma or GED certification) accompany the application.

WORK ELIGIBILITY:

Submission of completed job applications authorizes the University of Guam to seek and obtain information regarding the applicant's suitability for employment. All factors which are job related may be investigated (e.g. previous employment, educational credentials, and criminal records). All information obtained may be used to determine the applicant's eligibility for employment in accordance with equal employment opportunity guidelines. In addition, the applicant releases previous employers and job related sources from legal liability for the information provided.

Section 25103, Chapter 25, Title 10 of the Guam Code Annotated requires college or university employees to undergo a physical examination, to include a test for tuberculosis (skin or x-ray), prior to employment and at least annually thereafter. A report of such examination must be conducted by a licensed physician within a state or territory of the United States and must be submitted upon request.

Federal law requires presentation of eligibility to work in the United States within seventy-two (72) hours of reporting for employment. Specifically, 8 USC 1324A requires the employer to verify the identity and eligibility to work in the United States of all newly hired employees. Off-island applicants must obtain clearances from their place of residence. Applicants are responsible for fees associated with obtaining the clearances.
