MINIMUM QUALIFICATIONS:

Background in clinical psychology and be licensed in Guam with one of the following licenses:

- Licensed Clinical Psychologist
- Licensed Mental Health Counselor (LMHC)
- Licensed Marriage and Family Therapist (LMFT)

NATURE OF WORK:

This volunteer position will be a Clinical Psychology Consultant to assist the Isa Clinic with supervising student counselors, seeing clients and pending case conferences at the Isa Psychological Services Center for Academic Year 2020-2021 8 hours per week.

DUTIES AND RESPONSIBILITIES:

- Provide clinical supervision to the student trainees through both individual and group supervision modalities
- Participate in clinical case conference meetings where all new cases are presented and assigned. The clinical case conference also serves as a forum for Isa trainees to receive supervision and guidance on their psychotherapy cases in a group format.
- Provide direct clinical services to clients, including diagnostic evaluations, clinical assessment, crisis intervention, individual psychotherapy, couples therapy, and family therapy.

EDUCATION:

Applicants claiming degrees or credit hours are required to have an original or certified copy of the documents (e.g., Transcripts, high school diploma or GED certification) accompany the application.

ELIGIBILITY:

Submission of completed applications authorizes the University of Guam to seek and obtain information regarding the applicant's suitability for volunteer work. All factors which are related to the volunteer work may be investigated (e.g. previous employment, educational credentials, and criminal records). All information obtained may be used to determine the applicant's eligibility for volunteer work in accordance with equal employment opportunity guidelines. In addition, the applicant releases previous employers and job-related sources from legal liability for the information provided.

Section 25103, Chapter 25, Title 10 of the Guam Code Annotated requires college or those working at the university to undergo a physical examination, to include a test for tuberculosis (skin or x-ray), prior to performing volunteer work and at least annually thereafter. A report of such examination must be conducted by a licensed physician within a state or territory of the United States and must be submitted upon request.

Federal law requires presentation of eligibility to work in the United States within seventy-two (72) hours of reporting for work. Specifically, 8 USC 1324A requires the university to verify the identity and eligibility to work in the United States of all persons work at the university. The University of Guam is required to comply with this law on a non-discriminatory basis. If you are selected to fill a volunteer position within the University of Guam, you will be required to present valid documents to comply with the law.

POLICE AND COURT CLEARANCE:

Pursuant to Public Law No. 28-24 and Executive Order No. 2005-34, applicants selected for a position are required to provide original police and court (Superior Court of Guam) clearances of no more than three (3) months old prior to commencement of employment. Off-island applicants must obtain clearances from their place of residence. Applicants are responsible for fees associated with obtaining the clearances.


