Dr. Maria Claret Mapálad-Ruane is currently a tenured Professor of Economics at the University of Guam-School of Business and Public Administration (UOG-SBPA), the Resident Development Economist for the University of Guam-Pacific Center for Economic Initiatives (PCEI) and the Resident Development Economist and Research Contributor/Supervisor to the University of Guam-Regional Center for Public Policy (RCPP). She earned her B.S. (with Great Distinction) and M.A. in Economics from San Jose State University and her Ph.D. in Economics from the University of California-Riverside. She has 29 years of experience in International Macroeconomic Development, with focus in the area of policy formulation and the Asia-Pacific region. Dr. Ruane has written several socio-economic studies at regional, national and international levels, including RCPP's 2018 Guam Economic Report, "Factors that Explain Corruption in the 50 States of the United States of America: A Regression Analysis" published in the double-blind, peerreviewed, internationally circulated Asia Pacific Business and Economics Research Perspectives, and a 20-equation simulation model to analyze the effect of development aid on a recipient economy. Her other work includes contribution to the generation and analysis of much-needed economic and business indicators and analysis in Guam, including consumer and business confidence survey, buying local behavior, local spending multiplier, effect of exchange rate changes on tourist arrivals to Guam, local farmer and village residents surveys in the context of the One Village-One Product (OVOP) approach to Guam's economic development. She believes that research is a search for the truth and aims at developing local capacity in Guam to produce ethical, relevant and impactful economic research and analysis.

Ms. Efigenia Rose Barcinas is currently a Research Fellow at the RCPP, and graduated as *Summa Cum Laude* from UOG in Spring 2019 with a Bachelor's degree in Business Administration with a concentration in Finance and Economics. Post-graduation, she has gained employment with the Bank of Guam, and was recently accepted into the PMBA program at UOG. During her undergraduate studies, she has been included in UOG's President's List and held the title of Regent Scholar. Some of her other accomplishments include placing second in the 2017 CIS Conference Essay Contest, and being selected for the Tokio Marine Fellowship Program. In addition to her academic endeavors, she had previously gained work experience through internship programs at the Bank of Guam, a local law office and a newspaper company. Overall, she aspires to be in a leadership position that enables her to assist the people of Guam in making sound financial decisions so they may invest in opportunities that enhance wealth and value for themselves and their families. In addition, he plans to earn additional certifications such as becoming a Certified Management Accountant

She is very familiar with the importance of conducting ethical research, including the Institutional Review Board (IRB) process, as she was a member of the Committee on Human Research Subjects/Institutional Review Board at UOG. She also conducted the research climate survey, including designing the survey instrument, collecting data and writing up the reports. She is currently collaborating with faculty colleagues at UOG on several research projects, including "The Need for Developing Cyber-Security Program at Universities", "Corruption on Guam: A Comparison with other Countries/Territories", the first-ever to use the first-ever survey-based measure of corruption perception on Guam (patterned after Transparency International's methodology) and compare these survey results with those for other countries and territories, and "The Cost of Not Getting a College Education: A Case Study of Guam", a pioneering work that replicates the Pew Research 2014 report entitled "The Rising Cost of Not Going to College" for Guam through survey and use of Guam census data to compare Guam's results with those from the U.S. as well as with results from more recent surveys.

Ms. Luisa V. Tenorio is currently a Research Fellow at the RCPP and a co-author of RCPP's publications entitled the 2018 Guam Economic Report published in December 2018 and the 2015 Guam Corruption Perception report published in January 2019. She graduated with honors from UOG in May 2018 with a dual degree in Business Administration with a concentration in Finance and Economics and in Political Science and has completed courses equivalent to those required in Economics undergraduate programs in many U.S. universities. She plans to pursue a graduate study in the area of Politics, Economics and Statistics and thereafter add to the small number of economists on-island and has been admitted to a very prestigious university in Europe. She presented her research on income inequality among SIDS and was well-received at the ICBEIT in 2017 in Guam. It was submitted for double-blind peer-review by the Asia Pacific Business and Economics Research Perspectives and was invited to be revised and resubmitted. She presented a revised version of her research at the Sustainable Tourism Symposium by the SBPA-Tourism Awareness Group in December 2017. She continues to develop research expertise on the special and unique economic situations faced by SIDS economies (including Guam), with an interest in identifying appropriate policy implications and formulation and presented her research at the ICBEIT 2018 in Osaka and ICBEIT 2019 in Singapore. She served as a member of the ICBEIT conference organizing committee for three years. She has written a number of research papers on a wide range of economic and political issues where she demonstrated a deep understanding of both qualitative and quantitative/statistical research methods.

Ms. Angelina T. Tretnoff is currently a full-time Business Instructor at the College of Micronesia-FSM in Pohnpei and a Research Fellow at the RCPP. She graduated Magna Cum Laude in Business Administration with a concentration in Finance and Economics from UOG in May 2014. She also earned her Master's in Public Administration from UOG. She recently co-presented a paper on the topic of Social Development and Corruption: An International Comparison at the ICBEIT 2019 in Singapore. She has chaired several ICBEIT conference sessions as well as served as a lead member of the ICBEIT organizing committee since 2014 with Dr. Ruane, an awesome mentor and close friend. She aspires to be an economist like Dr. Ruane with hopes to be able to implement her research towards her country, the Federated States of Micronesia (FSM). She plans to do another research presentation at the upcoming ICBEIT in Sydney come March 2020 as well as serve for the first time as a conference co-chair to represent her institution, College of Micronesia-FSM, which joined partner institutions UOG, Nagoya University, Ritsumeikan Asia Pacific University, and Osaka Prefecture University.
