PUBLICATION AGREEMENT STORYBOARD 20

This Publication Agreement is made this ____ day of _____ 202__ between

CONTRIBUTOR'S NAME ("Contributor"), and the **UNIVERSITY OF GUAM**

PRESS/STORYBOARD: A JOURNAL OF PACIFIC IMAGERY ("UOG Press/*Storyboard*") of the University of Guam, a public, nonprofit land grant university, whose address is 303 University Drive (UOG Station) Mangilao, Guam 96923.

WHEREAS:

A. The Contributor has created an original work entitled:

(name of submission/submissions if multiple), "the Contribution", which

includes all writing, guides, illustrations and other relevant materials supplied by the Contributor;

B. The Contributor represents that (s)/he is the sole proprietor of the Contribution and that the Contribution to the best of his/her knowledge does not contain any libelous matter, does not violate the civil rights of any person(s), and does not infringe on any existing copyright or on any duty of confidentiality which the Contributor may owe to any third party;

- C. The Contributor wishes to grant their non-exclusive rights of publication to UOG Press/*Storyboard* to publish the Contribution in the 20th issue of *Storyboard*, in online/e-publications and marketing of *Storyboard*, and in future reprints/collections/marketing of *Storyboard*;
- D. The Contributor and UOG Press/*Storyboard* agree to enter into this Publication Agreement on the terms and conditions as follows:
1. The Contributor will grant non-exclusive rights of publication of the Contribution to UOG Press/*Storyboard*.
 2. The Contributor is responsible for identifying and bringing to UOG Press/*Storyboard*'s attention any third-party material that may be included in the Contribution and for assisting UOG Press/*Storyboard* in obtaining all necessary rights and other permissions to publish the third-party material in the Contribution.
 3. UOG Press/*Storyboard* at its own expense will graphically layout, print, market and distribute worldwide *Storyboard 20* and any future reprints of the journal online or in the form of a collection/anthology of *Storyboard* contributions.
 4. The Contributor shall retain all copyright for their work in the Contribution.
 5. UOG Press/*Storyboard* will retain all copyright for the collection of works in its entirety (the Contributor will only retain copyright for his/her work in the collection, but not the collection as a whole).
 6. UOG Press/*Storyboard* will not provide monetary compensation to the Contributor; however, two (2) complimentary copies of the Contribution will be given to the Contributor upon receipt of the full shipment of the printed version of the Contribution.

7. The Contributor agrees to indemnify UOG Press/*Storyboard* against any action, claim, proceedings, demands, loss, damage or injury and any costs or reasonable legal expenses incurred by UOG Press/*Storyboard* as a result of any breach or alleged breach by the Contributor of the Contributor's obligations, warranties and undertakings under this Agreement.
8. If any dispute or difference shall arise in connection with this Agreement, the parties will first meet to resolve the matter informally before resorting to mediation or other legal remedies.
9. This Agreement shall be governed by and construed in accordance with the laws of Guam.
